3. Executive Director's Report:

- Update of current events, information, operations, and programs
- Dr. Munoz, Executive Director, we had a couple of resource and job fairs at our campuses: Winston Intermediate School of Excellence, Gus Garcia University School, and the Burleson School for Innovation and Education in order to recruit teachers.
- Gus Garcia University School won the June Job Fair table decorating contest and took 1st Place.
- Dr. Munoz, Executive Director mentioned we had at WISE Summer SOAR Program that was first introduced by Dr. Socorro Garcia-Alvarado a year ago in 2021 for the rising 3rd graders coming to Winston Intermediate School of Excellence. Scholars were selected to attend the summer SOAR Program to ensure scholars were better prepared for 3rd grade readiness. Further, scholars were exposed to culturally relevant pedagogy and literature; students would engage in reading a book about tortilla making and then actually do tortilla making, or a book about a mariachi and then a mariachi would perform for students.
- Dr. Munoz, Executive Director mentioned the Gus Garcia University School Theatre Week, EISD and Magic Theatre provided 6TH, 7TH, 8th graders an opportunity to partner with Magik Theater designers and actors to create a skit and props and then at the end of the week performed a one act play using their hand-crated props.
- Thank you to Dr. Diana Wandix- White for her 2-year service as our Faculty in Residence at Gus Garcia University School.

3.A. Gus Garcia University School

- Ms. Husband, Principal of Gus Garcia University School was introduced to the ISCP Board of Directors for the first time. Ms. Husband and Dr. Salma Boyd highlighted some areas at Gus Garcia for the STARR May Results, sharing some on how students are performing, students in 8TH grade biology and Algebra I STARR scores led the entire EISD.

- Campus Updates- Dr. Michelle Janysek mentioned Truist Foundation for the Burleson School for Innovation and Education was awarded at \$30,000
