1. Call Meeting to Order: Board Chair, Olga Moucoulis, called the meeting to order at 4:30 p.m.

1.B. Pledge of Allegiance to US and Texas Flag – Board Chair, Olga Moucoulis, lead the National and State Pledges of Allegiance.

1.C. Moment of Silence- Board Chair, Olga Moucoulis, called for a moment of silence.

2. **Communication from Citizens: ISCP Executive Director, Dr. Henrietta Muñoz, stated that there were no communications from citizens.**

3. **Executive Director’s Report: ISCP Executive Director, Dr. Henrietta Muñoz, provided an update to the Board regarding the following key items:**

- **Dr. Muñoz provided an update of current events, information, operations, and programs.**
- **Dr. Muñoz announced that two new staff members (Faculty-in –Residence) had joined the ISCP. Dr. Salma Boyd- Gus Garcia University School and Dr. Sonia Sanchez- Winston Intermediate School of Excellence.**
- **Dr. Muñoz shared that an additional four faculty members from A&M were working to support the SB 1882 campuses. These are: Drs. Karen Burgard, Michael Boucher, Katherine Espinoza, and Catherine O’Brien.**
- **Dr. Muñoz stated that the new staff members had participated in an Educator Summit-a weeklong Professional Development the first week in August 2022 at Texas A&M University San Antonio.**
- **Dr. Muñoz showed Video from Gus Garcia University School and suggested that Board Members follow them on social media for the latest videos.**

3.A. Winston School of Excellence [Academic Year 2 Plans](#)

- **Dr. Sonia Sanchez, new Faculty-in-Residence for WISE discussed the Academic Year 2 Plan**
 - **Performance Measure 1 Enrollment Retention with attendance rate 88% want to get to a 93%.**
 - **Performance Measure 2 Academic Performance is 55 at meet master at 20%.**
 - **Reading & Math needs to be over 70%.**
 - **Performance Measure 4 Teacher Retention**
 - **Performance Measure 5 School Climate and Culture**

Funding Updates

- **In Dr. Janysek’s absence, Dr. Muñoz shared information on funding updates with the Board.**
- **Dr. Muñoz stated that WISE was the beneficiary of funding from a federal grant that had been awarded to Dr. Karen Burgard. The CULTIVAR Grant focuses on expanding arts integration and instruction in ASPIRE Network schools. CULTIVAR is providing cash funding in the amount of \$8,000.00 to WISE to pay for art supplies and to assist in paying for the mural that was partially funded by the NoVo Foundation.**

- **Dr. Muñoz also told the Board that the ISCP was working with the United Way of San Antonio and Bexar County to apply to the US Department of Education’s Full Service Community Schools Grant-Due Sept 12th. This grant would provide wraparound services at two ISCP managed campuses and would bring in additional funding to support two staff members. The grant provides 2.5 million grant over five years.**
- **Dr. Muñoz also told the Board that the ISCP was working with the United Way of San Antonio and Bexar County to apply to the US Department of Education’s Promise Neighborhood Grant- Due October 7th. Similar to the Full Service Community Schools Grant, but on a larger scale. It provides substantial investment in underserved communities. The grant, if awarded, would result in \$30 Million in investment grant over five years with community organizations providing an additional matching \$30 Million in investment.**
