3.A. Burleson School for Innovation and Education

- Grace Aguirre Garcia stated the AY4 Progress updates for Measure 1 and 2 Currently Burleson ADA 92% of our 28 student's enrollment count.
- AY4 Update Performance Measures 3 and 4 currently 21 of the 28 students (78%) are utilizing the Student LED IEP Model during ARD'S.
