### 3.A. School Transformation – Dr. Sonia Sánchez End of Data Information

- Dr. Sonia Sanchez presented preliminary test scores showing significant progress, with the school's accountability rating improving from an F to a 69 (D grade) and being one point away from a C rating. The school also

demonstrated growth in multiple academic domains, particularly in science and social studies, and successfully closed achievement gaps for special education, English language learners, and highly mobile students.

#### **4. Gus Garcia University School Mutual Release of Campus**

Consider approval of a mutual agreement between ISCP and Edgewood ISD to conclude ISCP's role as operating partner for Gus Garcia University School and transition operational responsibility back to the district. The transition is based on a shared commitment to serving the best interests of students, families, and the Edgewood community and authorizes the CEO to execute related transition documents.
