3. Chief Executive Officer's Report:

- Update of current events, information, operations, and programs
- Dr. Henrietta Munoz started out with Mission Statement for Institute for School & Community Partnerships
- ISCP Educator held on August 4, 2025
- Soft opening for Family Resource Center at Pecan Valley Stem Academy aimed at supporting families in need, with a formal ribbon cutting scheduled for October.
- The introduction of the School Transformation team included new members such as Curtis Wilson, the new principal of Gus Garcia University School, and Jeanette Morales, who will oversee the Toyota Driving Possibilities initiative.
- 3.A. Briefing on Partner School Design (Academic Year Plans) Dr. Sonia Sanchez, Dr. Salma Boyd
- Dr. Sonia Sanchez outlined the HB3 goals for 2025-2026 school year, focusing on metrics for student achievement and school progress, with current attendance at 91% and an enrollment of 711 students. The discussion also addressed staffing challenges due to the growing student population and the goal of 95% of students making progress on IEP goals, which was successfully met last year.
 - 3.B. Debrief of Educator Summit Gabriella Villegas
 - Ms. Gabby Villegas gave a debrief on the Educators Summit, emphasizing the key training on emotional intelligence and relationship building led by Dr. Wiliamson. Participants expressed enthusiasm for the new leadership at Gus Garcia and Burleson campuses, noting the event's logistical success. There was also a desire more time to discuss community history with Jesuscita.
